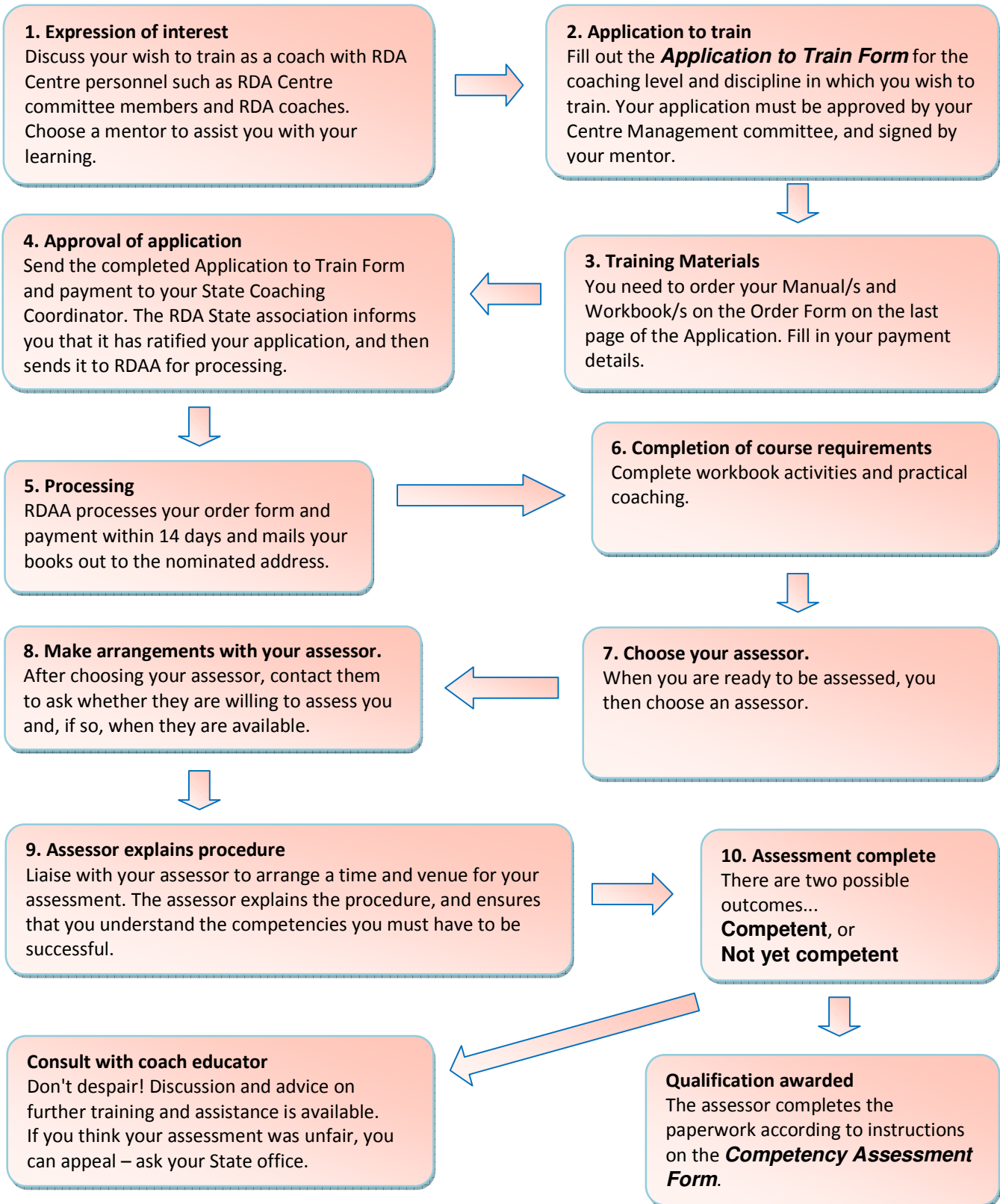




Procedure to Train as an NCAS RDAA Level 2 Riding Coach



Application to train – NCAS RDAA Level 2 Riding Coach

Information for Applicants

Who attends RDA Coaching courses?

RDA coaching courses are designed for volunteers with equestrian experience who wish to become RDA qualified equestrian coaches. You may have had experience as a rider yourself; you may already be a coach in another equestrian field such as Pony Club, EA or Adult Riding Club, or you may be involved as a volunteer with RDA.

What are the age and riding skill pre-requisites for the Level 2 course?

You must be:

- At least 18 years old at the time of commencing this course
- A currently accredited Level 1 RDAA NCAS Coach of at least 12 months
- Able to ride, or have previous riding experience, and specifically be able to show dressage movements and paces found in Para-equestrian Dressage Tests (grades 1, 2, and 3), and be able to ride over a small jump of at least 35 cm. Evidence of riding competency can be provided either by:
 - A live demonstration or a video of your riding
 - Written verification of current/previous riding experience from a Level 1 (or above) EA Coach or Level 2 RDAA Coach.

Note: If you have a disability, your case will be considered on its merits.

What does the Level 2 training package contain?

The Level 2 package contains a generic section that is common across all RDA training programs, plus a sports specific section for Riding, Carriage Driving or Vaulting, depending on your chosen equestrian discipline. Each section comes with an information training manual, a workbook for your answers and sign-off sheets for your mentor and assessor.

How long will the Level 2 training take?

It usually takes between 12 - 24 months to complete the Level 2 qualification. This depends on your previous background and how much time you spend training each week. You can take up to two years to complete the qualification and may apply for additional time by contacting your State RDA Office.

Before receiving the Level 2 qualification, you must complete the following requirements in the 12 months before your final assessment:

- Teach for at least 40 hours as a Level 1 Coach in an RDA Centre. Twenty hours of this teaching must be with RDA; the remaining 20 hours can be logged as a qualified coach (if you have this qualification) with Pony Club, EA or Adult Riding Club. To provide evidence of this, log your assistance hours on the **Hours of Coaching** log sheet (following page).
- Attend or present at two or more half-day coaching workshops conducted by qualified RDA coaches or persons approved by State or National Coaching Committees. Show evidence of this attendance on the **RDA workshop attendance record** sheet (page 6 of this form).

You must also hold a current Workplace Level 2 (Senior) First Aid Certificate from St John/Red Cross or another recognised service provider. To provide evidence of this, fill out the First Aid section on page 6 of this form, and attach a photocopy of your certificate.

In exceptional circumstances, any of the above requirements may be altered at the discretion of the National Discipline Committee or National Coaching Coordinator.

How will you deal with the private information I have included in my submission?

The information gathered on this form is entered into the National Coaching Accreditation Scheme (NCAS) database of registered coaches, maintained by the Australian Sports Commission (ASC) in conjunction with national sporting associations and state sport education centres. Coaches will be sent relevant up-to-date information, and may be contacted by the ASC. Your information will not be used or disclosed except in accordance with the provisions of the Privacy Act 1988.

Coach's Code of Ethics

1. Respect the rights, dignity and worth of every human being	<ul style="list-style-type: none"> • Within the context of the activity, treat everyone equally regardless of sex, disability, ethnic origin or religion
2. Ensure the athlete's time spent with you is a positive experience	<ul style="list-style-type: none"> • All athletes are deserving of equal attention and opportunities
3. Treat each athlete as an individual	<ul style="list-style-type: none"> • Respect the talent, developmental stage and goals of each athlete • Help each athlete reach their full potential
4. Be fair, considerate and honest with athletes	
5. Be professional and accept responsibility for your actions	<ul style="list-style-type: none"> • Display high standards in your language, manner, punctuality, preparation and presentation • Display control, respect, dignity and professionalism to all involved with the sport - this includes opponents, coaches, officials, administrators, the media, parents and spectators • Encourage your athletes to demonstrate the same qualities
6. Make a commitment to providing a quality service to your athletes	<ul style="list-style-type: none"> • Maintain or improve your current NCAS accreditation • Seek continual improvement through performance appraisal and ongoing coach education • Provide a training program which is planned and sequential • Maintain appropriate records
7. Operate within the rules and spirit of your sport	<ul style="list-style-type: none"> • The guidelines of national and international bodies governing your sport should be followed. Please contact your sport for a copy of its rule book, constitution, by-laws, relevant policies, eg anti-doping policy, selection procedures, etc • Coaches should educate their athletes on drugs in sport issues in consultation with the Australian Sports Drug Agency (ASDA)
8. Any physical contact with athletes should be:	<ul style="list-style-type: none"> • appropriate to the situation • necessary for the athlete's skill development*
9. Refrain from any form of personal abuse towards your athletes*	<ul style="list-style-type: none"> • This includes verbal, physical and emotional abuse • Be alert to any forms of abuse directed toward your athletes from other sources while they are in your care
10. Refrain from any form of harassment towards your athletes*	<ul style="list-style-type: none"> • This includes sexual and racial harassment, racial vilification and harassment on the grounds of disability • You should not only refrain from initiating a relationship with an athlete, but should also discourage any attempt by an athlete to initiate a sexual relationship with you, explaining the ethical basis of your refusal
11. Provide a safe environment for training and competition	<ul style="list-style-type: none"> • Ensure equipment and facilities meet safety standards • Ensure equipment, rules, training and the environment are appropriate for the age and ability of the athletes
12. Show concern and caution toward sick and injured athletes	<ul style="list-style-type: none"> • Provide a modified training program where appropriate • Allow further participation in training and competition only when appropriate • Encourage athletes to seek medical advice when required • Maintain the same interest and support toward sick and injured athletes
13. Be a positive role model for your sport and athletes

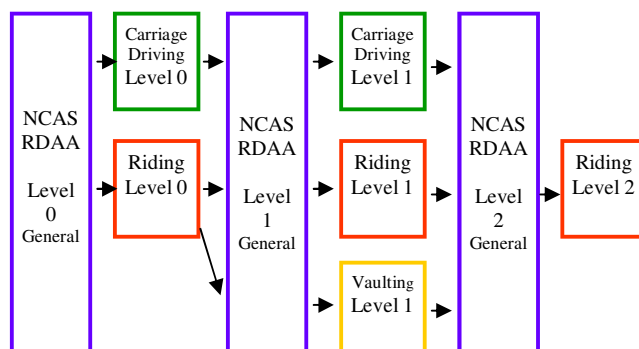
