

Life Member Nominations

Information for Nominations

An Honorary life member shall be a person who has provided positive and meritorious services to the Association and meets the criteria as set by the Association and whose nomination has been passed by the RDA Queensland Board and confirmed by most members present at the Annual General Meeting of the Association.

Criteria:

1. Has provided longstanding and distinguished service to RDA Queensland.

Length of service means total service at all levels of the RDA Queensland organisation (State and/or local Centre level). The application should include dates of when service commenced and length of time served at different levels of the organisation. Longstanding service is considered 10 years' service or more, however shorter periods of service may be considered where the service is highly distinguished. Distinguished service includes (but is not limited to) dedication to advancing the growth and prosperity of RDA Queensland, dedication to support of people with disabilities through RDA services, dedication to the support and training of RDA coaches and volunteers.

2. Service includes activities that benefit the national objectives.

Total service includes all activities within the RDA Queensland organisation however the nominee must also have contributed to the betterment of RDA at a national level through participation in specific national objectives. Examples include (but are not limited to) distinguished service on national Boards and national subcommittees, supporting coach training at national workshops, supporting delivery of national competitions.

3. The individual consents to being nominated.

Application process

Nominations must be submitted to the RDA Queensland Board of Directors at least 30 days prior to an Annual General Meeting. The RDA Queensland Board will assess applications against the criteria (as defined in the RDA Queensland Constitution rule 5:3) and put forward nominations for a vote of the Members at the Annual General Meeting. A nomination must include a written report outlining the history of service of the relevant nominee, together with comments on the suitability of the honour. Emphasis should be made on their service at a national level of the organisation. Nominations can be made by:

- any Voting Member by forwarding a proposed nomination at least 30 days prior to the AGM; or
- · the Directors.
